Consultation fee

- The fee is **fully deducted from the final price** if you proceed with a procedure (e.g. consultation € 50 + procedure € 300 → you pay € 300 total).

FAO Staff Coop discount

- Discounted prices apply exclusively to **verified FAO Staff Cooperative members**. The discount is **approximately 15%**; prices are rounded to the nearest € 5.

Combined procedures – package discount

- When **multiple procedures** are handled together, a **further discounted package price** can be agreed. Always ask us for a combined quote.

Instalment payments

- For **larger amounts** (e.g. permit conversion, family reunification, citizenship), payment **by instalments is available** and frequently used.

Revenue stamps & government fees

- **Revenue stamps (marche da bollo), government postal fees, court fees**, and other administrative charges are NEVER included in the prices shown and must be paid separately.

In-person accompaniment
